 - ii. We will use the existing nucleus of the GECRS structure of Area Groups, hence liaisons will be present. However the working groups should also include people teaching courses within the GE Area. Initial thinking has people on two-year staggered terms of service with no more than one person per department.
 - iii. It is assumed that not all members of the GECRS will want to engage in this work, hence syllabus review and review of GE courses will continue. However the Charge of the GECRS will need to be amended to reflect the work of the Area Working Groups.
 - iv. It is felt that the Graduation Requirements could be assessed in the following framework: Area A Writing Intensive, Area B nothing, Area C FORL, Area D American Political Institutions, Area E Race and Ethnicity in American Society.

- v. The Assessment Plan for GE Area Learning Outcomes should go through:
 - 1. GE/GRPC
 - 2. Academic Affairs/Dean for Undergraduate Studies
 - 3. Assessment Coordinator
