*AS 84-55, GPPC, Fisa, Ex. PRELIMINARY AND PROFESSIONAL ADMINISTRATIVE SERVICES CREDENTIALS

CSU Academic Senate November 1984 Meeting Highlights

- Faculty volunteers are needed to serve on GE challenge panels. This committee of 20 needs to become the committee of 40. Names of volunteers need to be to the CSU Senate Office by November 23.
- 2. The Senate is anxious to obtain a campus faculty member to be a Governmental Affairs Specialist to provide fast contact with local legislators when needed.
- 3. The CSU Senate is still receptive to input on the Statement on Collegiality in the CSU. Action proposed for January.
- 4. Trustee Dr. Dale Ride, in addressing the Senate, expressed his concern for the continuing role of the liberal arts at the baccaulaureate level. He feels there are questions about our entrance requirements if so many students need remediation when these students generally meet the admission requirements. We need to review the master plan from the viewpoint of the needs of the state rather than to protect our turf or building barriers between the segments. In advance, he declined to answer any questions about collective bargaining, although a member of that BOT committee. In answer to a question on the undesirability of differential salaries, he reiterated his belief in the value of a liberal education.
- 5. The Chancellor reported on her meeting with the presidents. All state agencies are under some pressure to reduce personnel. Areas in which this is achievable in the CSU must be outside that directly related to instruction (read this as faculty, clerical-academic areas, technical). They are talking about obtaining some of these reductions through additional automation and greater use of temporaries in areas where peaks and valleys in workload occur. The Chancellor restated her unhappiness with the current and not new comparison institution list and headquarter's efforts to do something about it. She indicated no knowledge about our cut of the windfall income deriving from the state lottery.
- 6. Notable among items the Senate considered was a redraft of the language of Area E of General Education (our Area V). Final action was not taken so that each campus can express its wishes about Area E, whether in the context of the proposal or in some other way. A straw vote among Senate chairs at Asilomar found one campus wishing to retain it as

is, 3 wanting to get rid of it, and 4 preferring some change. Contact your department Senator and make your thoughts known.

The Senate called for creation of a committee to study educational implications of the use of the high percentage of part-time faculty. They endorsed the system plan proposal to reduce remedial activity.

7. Dr. Bernard Goldstein (Biology-San Francisco) has assumed the chair of the state Senate to replace Jack Bedell who has become Acting Associate Vice Chancellor for Academic Affairs (Bob Bess's former position).

The Senate nominated the Faculty Trustee candidates whose names are next forwarded to the Governor.

- 8. It was reported by Senator Charnofsky that the 9th DCA recently determined that an award similar to EMSA's was not subject to income taxes. Recipients of EMSA's should consult with their tax advisors about this.
- 9. Of final and perhaps lasting interest the Senate gave time to Bill Christ, President of CFA, to report on his version of the situation in salary negotiations. One might view this as equal time since Trustee Brophy had obtained time at the Senate Retreat in Asilomar to present his perspectives on the same. You have all had an opportunity to read the press pieces published by both. One thing that is dawning on me in this process is the lack of involvement by system headquarters and the presidents in this process. Essentially, the Trustee committee is calling the shots from the system side and seeming not to consult with anybody including Trustees not on that committee.

I can't help but wonder if from the system side, since no one involved actually deals with day-to-day running of the CSU, the outcome desired related to education, students and the long-run quality of the CSU, its faculty or mission.
