- Time devoted to each group of items shall be limited to the time specified in the Tentative Schedule.
- 3. Items may be raised for discussion in the absence of a formal motion for adoption and reference to related items during debate on the item raised for discussion shall be considered in order.
- 4. Should an item be moved and seconded from the floor, substantive amendments introduced shall be considered for a first reading and any motion to suspend a first reading of any substantive amendment or the main motion shall be ruled out of order.

- 5. The Chair may, due to time constraints, depart from the order of the speakers list to provide preference to Senators who have not yet spoken.
- The Chair may depart from the order of the speakers list to provide for alternating pro and con arguments and responses to questions posed by a speaker.
