The Academic Senate recommends the following amendments to PM 86-02 "Procedures for Awarding Honorary Degrees" (see Agenda Attachment):

The membership of the Committee on Honorary Degrees be expanded to include two faculty at-large recommended by the Senate for appointment.

As part of the approval process for honorary degree candidates, following a recommendation by the Committee on Honorary Degrees the Executive Committee of the Academic Senate would be asked to consider and note to the President its endorsement or lack of endorsement of the recommended candidate(s). Deliberations regarding endorsements of candidates would be conducted in executive session and would be held confidential.

AS 92-103/Ex. PROGRAM REVIEW--COMPUTING, COMMUNICATIONS AND MEDIA SERVICES

Whereas, A principal function of the Computing, Communications and Media Services (CCMS) unit of California State University, Sacramento is to support academic programs; and

Whereas, There has been an explosion in the use of technology in academic programs; and

Whereas, There is increasing faculty demand for access to and support for alternative instructional delivery and personal computing; and

Whereas, CCMS must establish priorities and curtail its activities in some areas due to budget reductions; and

Whereas, The 1987 Program Review for the Department of Communication Studies included the following recommendation:

"that the Academic Vice President, in conjunction with the Vice President for Finance, the Department of Communication Studies, and the University Media Services, develop a formal, detailed, written statement of the mutual responsibilities and obligations of the Department and UMS concerning studio equipment and supplies purchases, studio and equipment usage, equipment repair, and equipment repair priorities, and

report back to the Academic Senate Curriculum Committee and Graduate Policies and Programs Committee by May 1, 1989"; and

AS 93-06/IP, Ex. ADVISING FOR INTERNATIONAL STUDENTS

The Academic Senate recommends adoption of the following:

Each academic department or program is encouraged to consider adopting a mechanism whereby a specific faculty member (or members) are assigned the primary responsibility of providing academic and professional advising to foreign students. Such advising would most usefully begin as soon as possible upon the student's arrival on campus.

A department or program choosing to adopt such a mechanism should send the name(s) of its faculty advisor(s) to the Coordinator of International Admissions in the International Admissions Office and to the Coordinator of International Students/Programs in the Office of International Programs. The Coordinator of International Admissions and the Coordinator of International Students/Programs will provide participating departments with the names of international students majoring in that department and will inform students coming from abroad about who to seek out for departmental advising. It will be the student's responsibility to contact the advisor, but the department or program will have provided the opportunity for her/him to do so.

MAS 93-07/AP, Ex. GRADE APPEAL PROCEDURES, PUBLICIZING

The Academic Senate recommends that the CSUS Catalog include the same information on grade appeal procedures as the Class Schedule, i.e.:

Grade Appeal Procedures

The campus has a single grade appeal procedure available to students in all academic disciplines. Copies of the procedure are available in each academic department office and Office of the Dean of Students.

AS 93-08/GPPC, Ex. HONORS AT GRADUATION FOR GRADUATE STUDENTS



The Academic Senate recommends the following:

Outstanding master's graduate shall be awarded "Master's Degree Awarded With Honors." The designation shall be awarded on the basis of the recommendations of the individual programs, and shall consist of not more than 15% of the master's graduates. Individual departments will be given a quota of students to be nominated based upon the past numbers of Master's degrees awarded by that program. Small programs will be given the opportunity to average over a several year period in order to accumulate the number of graduates which would enable them to recognize clusters of outstanding graduates. The designation shall be entered onto the student's transcript and diploma.

The Academic Senate further recommends the following CSUS Catalog copy:

Graduation with Honors, Master's Degree

Honors at graduation for CSUS Master's degree graduates will be awarded to not more than 15% of the graduates in a given year. Nomination shall be made by the individual Master's programs to the Office of Research and Graduate Studies.

Procedures for Awarding Honorary Degrees

The document attached contains the procedure to be used at California State University, Sacramento, for making recommendations to the Chancellor and the Board of Trustees on the award of honorary doctorates.

The Board's policy on the award of honorary doctorates provides for consultation by the campuses and encourages faculty, students, and other members of the University community to be involved in recommendations. Following the Board's direction, I charged an ad hoc committee on December 2 of last year with developing procedures for providing the consultation desired by the Board. The procedures are the result of the ad hoc committee's work.

The ad hoc committee also recommended that California State University, Sacramento, make no recommendations on honorary doctorates this year, but begin the cycle for producing recommendations with the start of the fall term. I am accepting this recommendation as well.

I wish also to thank the members of the ad hoc committee, Professor James Bosco, Dean John Colen, Professor Miriam Legare, Professor James Saum, Professor Peter Shattuck, and its Chair, Vice President Robert Jones, for their good work.

PROCEDURES FOR MAKING RECOMMENDATIONS ON THE AWARD OF HONORARY DOCTORATES

CALIFORNIA STATE UNIVERSITY, SACRAMENTO

In 1983 the Board of Trustees of The California State University established a policy permitting the award of doctoral degrees for three purposes: to recognize excellence and extraordinary achievement in areas that embody the University's ideals; to honor service to the University and the wider society; and to recognize men and women who might serve as examples for the University's student body.

Although the degrees are to be awarded by the Trustees and only in the name of the California State University, the Trustees outlined procedures for consultation with, and encouraged recommendations from, "any member of The California State University community." Recommendations originating in any of the campus communities shall be submitted through the campus President, who shall establish a committee to review recommendations and select no more than two nominations to be forwarded to the Chancellor.

The procedures to be used at California State University, Sacramento, for making recommendations on the granting of honorary doctoral degrees shall be the following:

- The Committee on Honorary Degrees shall be established consisting of six members:
 - The Chair of the Academic Senate;
 - The President of the Alumni Association;

 - The President of the Associated Students;
 The Chair of the University Staff Assembly;
 - 5. The Chair of the Community Advisory Board;
 - 6. The President

The members may be represented by a designee.

- The Committee on Honorary Degrees shall solicit and review campus nominations and make recommendations to the President. The Committee shall also assist in compiling material in support of the nominations forwarded to the Chancellor.
- The responsibility for managing the nomination process shall rest with the Office of University Affairs, which will provide staff to the Committee.

- 4. The Office of University Affairs shall prepare a memorandum containing a summary of the Honorary Degree criteria and a nomination form, and distribute the memorandum to the Campus Community during the second week of the fall term.
- 5. The calendar used to guide the process of recommending on Honorary Degrees is attached to this memorandum; the calendar may be revised as circumstances dictate.

Procedures for Awarding Honorary Degrees

On the recommendation of the Honorary Degrees Committee, I am making two changes to the University procedures for the award of honorary degrees.

Nominations for posthumously awarded honorary degrees will not be considered.

The calendar for recommendations for honorary degrees is amended. Each year, the first meeting of the Honorary Degrees Committee will be held in May, preceding commencement. The call for nominations to be issued by the office of University Affairs will occur on the first day of the opening of a new academic year. Recommendations from the Committee to the President will be made on approximately November 20, and the President's recommendation will be conveyed to the Chancellor by approximately December 1.
