Bylaws of the Faculty Senate. California State University Sacramento. Article III.B:

"2. Election of Chair and Vice Chair

"...the newly constituted Faculty Senate shall elect its officers at a meeting called for the purpose. The order of business shall be as follows: (1) election of the Chair, (2) election of the Vice Chair, (3) call for additional nominations for five elected members of the Executive Committee, (4) election of the five elected members of the Executive Committee. The election of the officers of the Senate (Chair, Vice Chair and the other voting members of the Executive Committee) shall be by secret ballot. The candidate for each office who receives more votes than any other candidate for that office shall be elected.

"3. Election of the elected members of the Executive Committee

"The manner of electing the other five (5) voting members of the Executive Committee shall be as follows:

- "1) If more than ten (10) candidates have been nominated, the Senate shall immediately select by secret ballot from among the several nominees ten (10) whose names shall be put to a vote in the subsequent election. When making this selection, each representative may vote for ten (10) candidates. In case of ties, the number of nominees shall be increased to include the tied candidates. Each candidate selected shall have received more votes than any candidate not selected.
- "2) When the candidates have been selected, the Senate shall immediately elect by secret ballot from among those candidates the other five (5) elected members of the Executive Committee. Each representative may vote for five (5) candidates. Each of the five (5) candidates elected shall have received more votes than any candidate not elected. In case of ties, the Senate shall immediately vote by secret ballot to break the tie. Each representative shall have one vote. The candidate(s) elected shall have received more votes than any candidate not elected." (over)

INTENTIONS:

I believe the changes made this year to the Senate Constitution, its By-laws and Standing Rules afford the opportunity for the Chair and the Executive Committee to provide the leadership required for more effective engagement of the Senate in the policy issues that are important to the faculty. These changes will require the Executive Committee to be more involved in the planning and organization of Senate's work. Prior to the start of the academic year the Committee now has the responsibility to plan the Senate's agenda for the year. In so doing, the Committee will 1) review actions taken in the prior year and identify carryover items that should be addressed, 2) identify key issues to be addressed by both the Senate and its Standing Committees, 3) set tentative agendas for the Senate and its Standing Committees, and 4) plan the program for the annual Faculty Senate retreat. During the course of the year, the Committee will meet at least one week prior to each Faculty Senate meeting to set and approve the agenda. The intent is to insure that the Senate can address key issues in the time allotted, and the agenda can be accomplished in one Senate meeting. Finally, with the addition to the Executive Committee of Senate Committee Chairs, I expect communication between the Committees and the Senate to be greatly improved. My hope is that these changes will provide Senators with time for informed debate and opportunities to decide on key issues in a timely fashion.

I believe we must continue to work with the administration and to maintain our collegial relationship. A major part of this work should be the completion of the charge given to the Ad hoc Faculty Governance Committee: to finish the review of university committees, to identify those governance areas where the Senate should reestablish its role, and to work with the administration to do so. I expect that the "interesting times" that have engulfed our University will continue. However, I hope that the Senate and the administration, together, can find ways to build a more trustful and productive relationship.

Finally, and most importantly, I am honored to serve as Chair and will do my best to represent the Senate in a manner that will reflect positively on all of us.

I believe my qualifications derive from two sources: education and experience. I have a doctorate in education with a major in curriculum and instruction. My experiences include teaching and committee participation at the Division, College and University level.

I have been teaching for thirty years, twenty of them on the CSUS campus. Three of the courses I teach in the graduate program focus on educational program development implementation and evaluation.

In the Division of Nursing I have been Undergraduate Curriculum Coordinator and Program Evaluation Chair. In these roles I was responsible for assuring appropriate curriculum development and implementation and for designing and implementing our program evaluation plan. I participated with the Division Chairperson in writing selfstudies and in related review processes for University program reviews as well as our state and national program accreditations.

At the College level, I have served as the Division representative on the Academic Council for six years. This, as you know, involves reviewing course and program proposals within the college.

At the University level, I have served on the Teaching and Learning Technology Roundtable. I was the Assessment Committee chair last academic year and continue on the committee this year. Last year I was responsible for planning and implementing four major distance education assessment initiatives. A summary of these assessment outcomes were presented to the Senate chair and to the Curriculum Policies Committee this year. I was selected to present these findings at the 75th annual WASC conference.

Also at the University level I have been a member of the Curriculum Committee for a total of eight years. In this role I have served on several Program Review teams. I have also been involved in developing numerous curriculum policies.

I am continuously interested in curriculum design, implementation, assessment and evaluation. I believe it is very important to support faculty in assessing their programs and in discovering ways they want to improve their curricula. In addition to my involvement with the Faculty Policies Committee, I have served as my department's Senator from 1993-96. I have been chosen as the nominee of the General Education Policy/Graduation Requirements Committee (GEP/GRC) for 1999-2000 committee chair.

I have served on the GEP/GRC for all academic years since 1990-91 except for 1992-93. I have served as GEP/GRC chair for the past three years. My experience in both serving as committee member and chair is my primary qualification as nominee for 1999-2000 chair.

During the past three years, GEP/GRC developed and administered GE area assessment questionnaires for Area B2 Life Forms and Advanced Study. A questionnaire for Area B1 Physical Science was developed and will be administered in Spring 1999.

Additionally, GEP/GRC has begun an evaluation of the current General Education program. Last Spring, GEP/GRC developed and administered a faculty GE poll. Based on that initial poll, a faculty GE questionnaire was administered earlier in Spring 1999. The committee is currently tabulating and assessing the results of the questionnaire. During the Fall 1998 CASPER registration, a student questionnaire on the GE program and graduation requirements was administered and the results assessed. All of the data gathered with these questionnaires and the poll will be used for the GE program review that will take place in 1999-2000.

One of the primary tasks of GEP/GRC in 1999-2000 will be participation in the General Education program review process. The GEP/GRC will write the General Education program self study document and will be otherwise involved in the review process.

Additional tasks that face GEP/GRC are to continue the GE Area review process. During 1999-2000, Area B will be examined for course compliance with Area criteria and assessment questionnaires for Areas B4 Quantitative Reasoning and B5 Further Studies will be developed and administered.

Other issues before GEP/GRC include assessment of graduation requirements, gathering information regarding compliance with the computer literacy/information technology policy, and initiating assessment of Area C.

My intention with regard GEP/GRC is to continue the ongoing work of the committee and to oversee the committee's role in the program review process.
