*FS 01-10/Ex., Flr. 120 SEMESTER UNIT REQUIREMENT, RESOLUTION ON

[BACKGROUND: In July 2000 the Board of Trustees of the California State University approved changes to the Bachelor's Degree requirements* by setting a new minimum of 120 units (the old minimum was 124 units). With this change, students must still fulfill all of their graduation requirement, however if after doing so they have accumulated at least 120 units, they can graduate. The change goes into effect beginning with the 2000-01 academic year.

This resolution is intended to modify the information contained in the CSUS 2000-2002 Catalog (page 77) and all related advising sources of information.

For many programs, the combination of 51 units of General Education (GE) and the unit requirements in the major exceed 120. The resolution/policy does not mandate that these programs reduce their unit requirements.]

WHEREAS: The Board of Trustees of the California State University has set 120 as the

minimum number of semester units required for awarding the Baccalaureate

degree; and

WHEREAS: The faculty of California State University, Sacramento has primary

responsibility for academic programs and policies; therefore be it

RESOLVED: That, student graduation requirements shall include completing 1) the University's General Education requirement--51 semester units, 2) the foreign language proficiency requirement, 3) the second semester composition requirement, 4) the course/unit requirement in the major, and 5) a total of at least 120 units (inclusive of the GE, foreign language, composition and major unit requirements); and be it further

RESOLVED: That students that meet their non-GE requirements with less than 69 units shall be required to accumulate additional units to reach the 120-unit minimum; and be it further

RESOLVED: That students that meet their non-GE requirements with 69 or more units are unaffected by this change and still must complete all their non-GE requirements; and be it further

RESOLVED: That the application deadline for spring and summer 2001 graduation should be extended without penalty to allow students that have completed their GE and major requirements and accumulated the minimum of 120 units to apply for graduation this academic year; and be it further

RESOLVED: That the University Catalog and all student advising information be updated to reflect the change in the minimum semester unit requirement.

FS 01-11/Flr. FACULY MERIT PAY POLICIES, SUPPORT FOR CSU ACADEMIC SENATE RESOLUTIONS REGARDING

The Faculty Senate of California State University, Sacramento endorses and supports:

CSU Academic Senate Resolution (AS-2516-01) "Urging Outside-of-Bargaining Assessment of Merit Pay Policies", approved January 18-19, 2001 (see *February 15*, 2001, Faculty Senate Agenda Attachment F-1).

CSU Academic Senate Resolution (AS-2523-01/FA) "Merit Pay Principles and Future Contract Bargaining", to be acted upon at the March 15-16, 2001 meeting of the Academic Senate (see February 15, 2001, Faculty Senate Agenda Attachment F-1).

*FS 01-12/Flr. FACULTY MERIT PAY SYSTEM, ESTABLISH WORKGROUP TO ARTICULATE PRINCIPLES AND GOALS OF

WHEREAS:

While it is the prerogative of the Union to bargain on faculty salaries and to fight for equitable treatment for faculty, the goals and philosophy behind faculty retention and promotion are the prerogative of the faculty. It is not wise or sensible for the faculty to cede these concerns and responsibilities to the Union and the market-driven vagaries of the bargaining table. Such an abandonment of our duties will result in the incoherent and poorly thoughtout compromises that we have seen in previous Merit Pay Programs; therefore be it

RESOLVED:

That on the CSU Sacramento campus, a working group be formed consisting of faculty senate leadership members, other interested faculty, and central campus administration to hammer out and articulate the goals of Faculty Merit Pay and a sense of how this program might improve our campus, rather than devastate and divide it; how it might articulate a vision for our campus that both faculty and administration might buy in to; and be it further

RESOLVED: The working group should complete its work and report to the Senate by the end of the spring semester. Furthermore, if the Senate approves, the report will be immediately delivered to the Chancellor's Office, CFA, those parties involved in the "Outside of Bargaining" discussions, and the statewide Academic Senate. The intent is to better inform the parties involved in the negotiations with the hope of avoiding an "agreement" containing another incoherent and poorly thought-out merit program.
