The Faculty Senate recommends amending the guidelines for the Pedagogy Enhancement Awards Program as follows:

II. Eligibility

An individual faculty member may receive no more than a total of 12 units of assigned time per year and no more than 9 WTUs in any one semester from any one or combination of the programs included in the Faculty Professional Development Implementation Plan, available through the Center for Teaching and Learning 1992-93. In addition, an individual faculty member may receive either a Research and Creativity Activities Award or a Pedagogy Enhancement Award, but not both, in any given academic year.

The Faculty Senate recommends amending the guidelines for the Research and Creative Activity Award Program as follows:

II. Eligibility Requirements

Probationary and tenured CSUS faculty in Unit 3 are eligible to apply for all programs. Full and part-time temporary faculty are eligible to apply for monetary support but are not eligible for assigned time or a summer fellowship. Please note that funding for temporary faculty is contingent upon that faculty member receiving a contract indicating an intent to employ for an average of at least six weighted teaching units per semester. In addition, an individual faculty member may receive either a Research and Creativity Activities Award or a Pedagogy Enhancement Award, but not both, in any given academic year.

ASSOCIATION POSITION IN CONTRACT BARGAINING

The Executive Committee has placed the following resolution on the agenda at the request of Peter Lund and does so without recommendation:

PROPOSED RESOLUTION for CSUS Faculty Senate: Support for the California Faculty Association Position in Contract Bargaining

WHEREAS: Collective bargaining on the 2001-2003 contract between the CSU and the CFA has commenced; and

WHEREAS: This contract will significantly shape the future direction of the CSU and the faculty's professional role in the CSU; and

WHEREAS: The CSU administration's contract proposals constitute an erosion of the interests of the faculty and the students of the CSU; and

WHEREAS: The CFA contract proposals advance the interests of the faculty and the students of the CSU; and

WHEREAS: The CSU administration has proved obstinately inflexible in past bargaining, failing to bargain in good faith, to compromise, and to accept recommendations from fact-finding; and

WHEREAS: The California Public Employee Relations Board has charged the CSU administration with violations of state law in its bargaining practices and is currently conducting a hearing on those charges; and

WHEREAS: An unprecedented imposition of a contract occurred in 1999 and was reversed only following significant pressure on the Chancellor by the members of the CFA; and

WHEREAS: Imposition occurred again in 2000 with the re-bargained contract provisions; therefore, be it

RESOLVED: That the Faculty Senate of CSUS supports the CFA position in current contract bargaining; and be it further

RESOLVED: That this statement be communicated to the faculty senates at all CSU campuses, the Statewide CSU Academic Senate, the Office of the CSU Chancellor, the CSU Board of Trustees, and the faculty of CSU, Sacramento.
