5. Security (Mark Hendrix)

Mark has 25 years in the CSU (recently Chico). He has contributed to many CSU security standards.

Message: Security is to protect people, particularly students. We have all sorts of information that could be used to steal someone's identity or other nefarious purposes.



Upcoming approaches:

PhishMe Campaign to train users about Phishing (people fall for Phishing all the time!)

2-step verification with Duo (for uses with access to level 1 data)

Changes to our password standards

General awareness campaigns

Security Audit

We had a security Audit in Dec 2017. They had 11 "findings". 8 have been fixed, 2 almost fixed, one needs substantial work (e.g., inventory and assessment of protected data, awareness of level 1 vs level 2 vs level 3 data, etc.). We have the Identity finder tool to look for sensitive data. EU GDPR will be important in the near future, e.g., the right of people to be "forgotten". How does that affect us?
