FS 13/14-109/FPC/EX President's Award for Research and Creative Activity Award Title, Amendment Of:

The Faculty Senate recommends approval of the name change of the "President's Award for Research and Creative Activity" to be the "University Award for Research and Creative Activity, effective Fall 2014.

University Award for Research and Creative Activity

This award, created for the purpose of honoring a colleague who has made significant contributions within the previous five years to a discipline through scholarly activity, creative/artistic endeavors, or research and publication, was first given in 1989. Unlike the Outstanding Scholarly Achievement Award, which tends to be given for the accumulated contributions of a lengthy career, this award is given to:

- · faculty during the first 10 years of their appointment (either full-time or tenure track);
- candidates whose research was carried out in the past five years, with emphasis placed on work accomplished at Sacramento State; and
- candidates who have held a full-time, tenure track position on the Sacramento State campus for three of the past five years.

The award includes a professional development grant of \$1,500 for use by the recipient to further their research or creative activity.
