FS 17/18-103/FL Memo to Academic Units informing them of Changes to the Role and Responsibilities of the Department/Division Chair Policy

(FS 17/18-48/FPC/EX)

The Faculty Senate recommends that academic units be provided guidance regarding changes to the Role and Responsibilities of the Department/Division Chair, if adopted by the President, as follows:

- 1. That guidance, in some form, be provided by the President's Office or, if delegated by the President, by the Division of Academic Affairs, in consultation with UARTP (as the Senate Committee charged with reviewing department/division policy/procedure documents).
- 2. That such guidance be provided within one month of the adoption of revised policy language or, if provided later that the implementation date of the policy be amended such that departments/division can adequately prepare for Chair elections.
- 3. That the revised provisions of the policy are made clear in nature and scope, including the extent of department/division discretion, but avoiding the use of examples in the form of language which might appear prescriptive.
- 4. That if the policy is adopted in a form that retains (as recommended by the Senate) variation in the apportionment of voting rights to temporary faculty at the department/division level (assuming the question of eligibility to vote for all temporary faculty is affirmed, as also recommended by the Senate), such variation is to be defined by appointment-based categorical status and not by individual status.
