## 3. Summary of Action in the AY 2017/2018 Faculty Senate

The following items were acted upon by the Faculty Senate in AY 2017/2018:

• **FS 17/18-133a**, GSPC Memo Recommending that Exec place the AuD Program Proposal on the full Senate Agenda. The memo was included on the April 5 Senate agenda; the AuD Program was eventually approved by the Senate.

- Significant discussion of President's Graduate Education Task Force Report, which was initiated by the Report's publication and a referral by Exec. GSPC forwarded its Prioritization of the Report's Recommendations, which was included as **EX 17/18-175** on the May 8 Exec meeting, to be shared with the Senate at the next available Senate meeting.
