 - Travel reimbursement: The campus recognizes there is an issue with timely reimbursement of travel expenses, which typically take at least 3 weeks to process. Travel advances are available to all faculty and are processed via travel requisition by the department's admin support. Faculty can sign up for electronic funds transfer, which requires an in-person visit to Procurement & Contract Services to complete the sign-up. The campus has recently introduced an alternative payment option where departments can request a campus US Bank card which can be used to purchase airline tickets and car rental in advance. The campus is also considering issuing personal travel cards in the future and will introduce a new travel system called Concur as early as next year.
