# CALIFORNIA SB 520 (STEINBERG), RECOMMENDATION TO AMEND TO BETTER ACHIEVE ITS OBJECTIVE OF PROMOTING HIGH QUALITY ONLINE INSTRUCTION IN CALIFORNIA HIGHER EDUCATION

The Faculty Senate endorses the following resolution to amend California SB 520 (Steinberg) in order to better achieve its objective of promoting high quality online instruction in California higher education;

Whereas: "SB 520 - Student Instruction: California Online Student Access Platform" was introduced by

> Senate President Pro Tem Darrell Steinberg with the commendable goal of pursuing "a facultyled process that places the highest priority on educational quality through which online courses

can be subjected to high-quality standards and review" (SB 520, Sec. 2.b.3); and

Whereas: Faculty-led processes already exist (e.g., general education course review, CI-D) that ensure

educational quality for all course offerings within and among each of the segments of California

public higher education; and

Rather than using extant processes, SB 520 requires the California Open Education Resources Whereas:

Council (COERC) to create and administer the Platform, which tremendously exceeds the

group's original purpose, scope of work, and expertise; and

Whereas: "Online course providers" not affiliated directly with an accredited higher education institution

and offering courses "open to any interested person" (SB 520, Sec. 2.b.1 and 2.c.1.B.2) bypass

the very quality control processes that SB 520 seeks to champion; therefore be it

Resolved: That the Faculty Senate of California State University, Sacramento concur with the analyses of

> additional problems in SB 520 offered by the Executive Committee of the Academic Senate CSU (letter of April 4) and the Chair and Vice Chair of the University of California Academic Council

(letter of March 15); and be it further

Resolved: That the Faculty Senate implore Senator Steinberg and all interested stakeholders to collaborate

in amending SB 520 to achieve its laudable objectives using existing faculty-led processes to

ensure educational quality; and be it further

Resolved: That SB 520 and any similar legislation abide by several key principles, among which are:

> 1) All classes offered for credit in California Higher Education should be taught by faculty-ofrecord who have been hired and evaluated according to established professional standards;

2) All classes offered for credit in California Higher Education should be approved by the

offering campus according to established curricular standards;

- 3) These standards are fundamental and should apply equally to all sectors of California Public Higher Education; and
- 4) Faculty should welcome Legislative support and resources to foster innovation and technology in teaching, provided that the support respects our professional and curricular standards; and be it further

Resolved:

That copies of this resolution be distributed to Senator Steinberg and all members of the California State Legislature, to the Academic Senates and Administrations of all institutions of California Public Higher Education, to the California Faculty Association, and to the press.

COURSE/PROFICIENCY REQUIREMENTS IN WRITING, SECOND SEMESTER COMPOSITION REQUIREMENTS FOR GRADUATION WITH A BACCALAUREATE DEGREE, DISCHARGE OF

The Faculty Senate recommends amending the General Education Program Policy, Section II. B.2. Course/Proficiency Requirements for Graduation with the Baccalaureate Degree, Course/Proficiency Requirements in Writing, Second Semester Composition Requirement (FS04-27A, Ex.; Policy File Number: FSG00020.htm (2006), <a href="http://www.csus.edu/umanual/acad/fsg00020.htm#SecondCompositionRequirement">http://www.csus.edu/umanual/acad/fsg00020.htm#SecondCompositionRequirement</a>, II B2 and all pertinent documents to remove the Second Semester Writing Requirement effective Fall 2013.

#### Second Semester Composition Requirement

#### a. Course Requirement

All students, including students who have completed the IGETC shall be required to complete a second semester composition course with a C-grade or better. The requirement is a graduation requirement, not a G.E. requirement. Composition/critical thinking courses taken to satisfy CSU G.E. Breadth Requirements or IGETC requirements do not necessarily satisfy the requirement. Second semester composition courses taken at other institutions may satisfy the requirement if they are determined by the Sac State English Department to be equivalent.

# b. Criteria for Courses Satisfying the Requirement

Courses meeting the requirement shall normally be lower division courses and shall focus on composition writing and on reading. Generally, the course shall continue instruction and practice in the kinds of writing tasks introduced in English IA and shall include readings in and writings based on multicultural literature. Course grades shall be assigned primarily on the student's demonstrated writing ability. The curriculum of the course shall emphasize the following:

- a review of composition principles
- continued work on the thesis, organization, development
- continued work on revision
- close reading of texts
- summarizing texts in writing
- reviewing texts in writing
- evaluating texts in writing
- integrating texts of others into students' own prose
- constructing an argument, martialling evidence, persuading
- research techniques
- writing longer papers than are required in IA
- refining style
- writing precisely and concisely

The motion was not agreed to.
