- Krabacher summarized discussion of EO1100 and EO1110 at the recent September 2017 statewide academic senate meeting: Key points included:
 - AVC Chris Mallon's explanation for the eliminate of Area E from upper-division GE;
 - Fact the two campuses (Sonoma, Monterey Bay) have requested and received extensions of the deadline for the executive orders;
 - The academic senate has requested a delay in the implementation of both executive orders until Fall, 2019. Other stakeholder groups, including CSSA, have already made this request.
- In anticipation of the increased workload, chair Peigahi is working to expand the membership of the GE Course Review Subcommittee.
