  - a. eLearning Policy the committee would like to review this policy prior to taking it to Executive. There are specific concerns about who can administer Online courses. Also the committee would like to explore differences that exist with face to face courses. Currently, the policy



embodies the philosophy that online and face to face courses are equal. There is confusion in departments as to how to designate a course as online.

- b. Honors Policy this has not passed the Senate as yet. Next step is to consult with the Philosophy department to make sure there is no conflict with the criteria for designating Honors courses/programs. Need to consult with Matt McCormack.
- c. Co-Curricular Policy Currently allows for 15 units of co curricular units. The old policy needs to be updated to avoid conflict with EO 1071
- d. Supplemental Instruction This is a referral from Executive Committee. The committee needs to clarify the referral from Executive Committee.
