- b. Faculty Senate and Senate Executive Update
 - Special Majors Policy will have 2nd reading on Thursday: need input related to feedback during first reading (e.g. minimum GPA, 3 academic majors needed)
 - Discussion:
 - i. Arguments for 3 academic units rather than 2:

- 1. Special majors are designed for students who have unique academic goals.
- 2. They cater to students' specialized interest.
- 3. By definition, special majors are not supposed to duplicate existing degree programs, minors, or certificates. As such, it needs to be distinct enough so as not to look like half of one degree and half of another.
- 4. The intention is that it be unique.
- 5. What we do NOT want it to be is a way to make already-completed courses "count".
- ii. Arguments for GPA of 3.0 minimum to enter a special major
 - 1. Due to the nature of the Special Majors, the special major student should be self-directed and motivated. These are students who can adapt to new environments, integrate knowledge from different sources, and continue learning throughout their lifetimes. Those students tend to have higher GPAs.
 - 2. The special major students must articulate an integrative and coherent theme. As such, they know what their interests are and how to argue for them.
 - 3. The Special Majors should NOT be for someone who is floundering and seeking a way to graduate somehow or some way
 - 4. Sacramento State GPA is right around 3.0 for all students, so we are in the correct range.
 - 5. We also heard arguments for students who discover a future needs in the job market and cannot find a major to suit their needs, so they create one.
- c. Report from Graduate Dean (Chevelle Newsome)
 - This morning GSPC passed the credit hour policy for credential programs.
 - Implementing an electronic graduate admissions process to hopefully go live October 1, 2014
- d. Report from Associate Dean for Undergraduate Studies (Sheree Meyer)
 - Moving forward on implementation for directed self-placement. Alternative to test-based placement for English. It will be a two-year plan for implementation. Platform has been selected combo of SacCT and a data warehouse.
 - Dept of Econ has a TMC. Has confirmed to offer a "compatible" degree for Associate's degree in Business Admin.
 - Clarification of 2nd bacc policy (from any accredited university) and American Institutions requirement: not held to American Institutions requirement.
