Old Business: Response to interim policy "Sacramento State Policy and Procedure on Conferring Degrees on Students Not Applying for Graduation Who have completed Degree Requirements"

The committee agreed to add the following language at line 26:

Deans and chairs in the colleges and departments will identify who appear eligible to graduate based on academic program requirements. Chairs or their designated student advisors will require each student to meet with them to discuss reasons why the student has not applied to graduate. The chair will make a recommendation to the College Dean about whether or not to proceed with the degree conferred process described here. Failure of a student to attend a meeting with the chair (or designated student advisor), given an appropriate time to do so, will

 $result\ in\ the\ Dean's\ recommendation\ being\ forwarded\ without\ student\ output.$
