1. Information Items

- a. Faculty Senate and Senate Executive Committee Update
 - From the Senate, Fell reviewed an information item presented in the Senate on the Sustainability at Sacramento State. Ryan Todd (sustainability manager) discussed a goal to achieve a high sustainability rating with AASHE - STARS (Association for the Advancement of Sustainability in Higher Education – Sustainability Tracking Assessment & Rating System). Fell also announced the call for the annual Livingston lecture and reviewed a resolution passed by the Senate for open presidential searches in the CSU system.
 - From the Executive Committee, Fell discussed revisions to the Faculty Responsibilities policy, Office Hours policy, and Emeritus Faculty policy.

- 2. Approval of minutes from September 15 and October 6 approved

3. Discussion Items

- a. Old business
 - e-Learning policy revisions
 - Discussed most recent revisions to e-learning endorsement form. In discussing if the form's objective is to approve a faculty member to teach the course or to approve a department to offer an online course, it was brought up that courses belong to a department, not a faculty

- member. This would suggest the form should act to approve the course to be offered online.
- o Fell asked if the committee believed that the e-learning modality was different enough to require additional approval. The committee agreed that the modality is different; Gibbs stated that in the current higher education environment, the general agreement is that online learning is a very different mode. She also recalled a study at the community college level regarding e-learning, mentioning one of the conclusions of the study was that underserved population of students have difficulty with online learning, and Sacramento State has many students like that.
