Sheppard recommended that Exec review the position job descriptions before nominating faculty to serve and suggested the Provost be invited to discuss the positions with Exec. It was also suggested that a pool of names be compiled and retained with the Senate Analyst for Exec to act on over the summer.

Peigahi nominated two faculty for the Senior Vice President, Planning, Enrollment Management and Student Affairs Search Committee: Carlos Nevarez (EDU) and Ann Bradley (Library).

Exec will move forward with putting together a list of faculty representatives and will recommend one faculty representative for each search committee. Announcements will be forthcoming

- 5. **Committee Appointment: Grade Appeal Procedural Appeal Board Nomination:** The Executive committee received the endorsement of Dr. William Dillon to continue service on the committee and a motion to place his name on Consent was made.
