- Course Leaf CAT and CIM Implementation Team: A faculty representative from each of the four Senate Committees below will serve on the Implementation Team. A call will be sent out to the four committee chairs.

- Vice Provost Search Committee: Faculty representative nominations will be reviewed by the Executive Committee at their September 13 meeting for placement on the September 22 Senate Agenda.
- **Program Impaction:** The Senate Chair is working with the Provost to address the requirement (FS 14/15EX-87) of a program data table being produced annually and a report on when programs became impacted, dates the campus has to approve the programs status (every 4-years), and the status of the program now. This report would be helpful to the Senate. (*See Discussion Items below*.)
- From the President: Dr. Nelsen welcomed everyone back and briefly spoke about the 1% budget cut, the increase in the number of classes students are able to enroll in, the New Faculty 2016-17 webpage, and the Graduate School Task Force. (See Discussion Items below)

DISCUSSION ITEMS

- Senate Meeting Dates: Exec discussed the Senate meeting every other week (Thursdays) during the academic year, except for the first week of instruction. The Senate has been meeting on the 1st and 3rd Thursdays, and Senators held the other Thursdays in case business warranted a meeting be held. The change would be minor to the schedule. The new schedule will be effective beginning Fall 2016. The Faculty Senate Standing Rules will be updated to reflect that the Senate will meet every other week of the academic year, except for the first week of instruction. This change does not affect the Faculty Senate Constitution or Bylaws. The Senate will be advised.
- September 8 Senate Agenda: Faculty Senate vs. Academic Senate: The item will be placed as an Information item on the September 8 agenda. Tom Krabacher will present a brief history of the Senate and the information will be added to the new Senate Handbook. A more detailed conversation with the Senate will take place in late September or early October.
- Guest Speaker Reimbursements: Concern was expressed about the length of time (6 weeks to 6 months) it takes for reimbursement of travel and honorarium payments for guest speakers and how that process is handled. It was suggested that an Office be designated to deal with Event Coordination not only for scheduling of the event but also for reimbursement. The Provost and Senate Chair will follow-up.
- **Program Impaction:** Exec discussed information that would be helpful to the Senate: Program data table, program status, the Lascher Report and the Impaction Task Force report. A copy of the Task Force report will be shared with the Executive Committee.
- **EO 1071 Revision Consultation**: The item will be referred to APC, CPC, FPC, and GSPC for review and commentary. Committees will be asked to respond no later than noon on September 12. The item will be placed on the September 13 Exec agenda and the response will be shared with the President before submitting to the ASCSU Chair. Questions were raised about whether or not programs should be asked to address now the changes outlined in EO 1071. The discussion will be continued at the September 6 meeting to allow Dean Newsome and Kace Chalmers, Curriculum Committee Chair, to participate in the discussion.

- **Program Proposals:** The proposals were reviewed and will be placed on the September 8 Senate agenda. (*See Action Items above*).
- Handbooks and Policy-related Documents: Exec reviewed the draft documents and will provide feedback to the Senate Analyst by Friday, September 2. Final drafts of the documents will be placed on the September 6 Executive Committee agenda.
