Executive Session: Administrative position

## **Open Forum:**

- Assigned Time for Exceptional Service Award: A question was raised about whether or not a faculty member is eligibility to apply for an additional award, if they received an award for the current AY and have not completed their project or submitted the required report. The item was added to the agenda as #13.
- Mental Health Presentation: The President asked that the presentation be provided to the Faculty Senate.
- Caption video: Some senators have been in communication with Public Affairs regarding video
  captioning on the Sac State Facebook and presentations to the Senate. It is important to support
  inclusive access to multimedia produced by the university.
- Graduation numbers: Concern was again expressed that the nature of the Finish in Four message
  does not frame to students the importance of the Liberal Arts Foundation. We should be speaking
  about exploration and major change when necessary.

### From the Chair:

- Information Item: General Education Task Force Report, Recommendations for GE Review and Reform.
- Feb 7 Senate meeting recap re: First Reading. Exec was asked to think about the conduct at the meeting regarding the BS in Human Development and Family Studies Program Proposal and how best to facilitate 2<sup>nd</sup> Reading.
  - o Advise on proper protocol, including questions vs auguring
  - o The Second Reading conversation has the ability to damage long-term relationships. Need to consider framing of conversation during Second Reading.
  - o There are ways to present business to the Senate by laying out a rational, inviting discussion so that it is less contentious.
  - o Items that are contingent and edgy, maybe a third party present each party's side.
  - o The Chair asked for a motion to add the item to the agenda as #14 First Reading Presentation.

**Calendar Policy:** The item will be placed at First Reaching on the March 7 Senate agenda with a 2<sup>nd</sup> Reading scheduled for March 14. A discussion regarding presentation of the item followed and it was determined that the Status Quo Model I calendar will be placed on the agenda. The supporting documents will include the ASI's resolution supporting the Status Quo calendar and a statement that the Executive Committee support the Status Quote Model I in accordance with the ASI resolution.

University Policy and Procedures: The policy establishes standards regarding the establishment, amendment, maintenance, and decommission of University policies and procedures. The President stated that the policy will be reviewed by the Senate and then other consultation will take place as needed. The item was referred to the Faculty Policies Committee with the request that they consult with other Standing Policies Committees and forward their recommendations to the Senate Chair by April 16.

Establishment and Administration of Endowed Chairs and Professorships Policy (draft): The policy provides guidelines for the establishment and administration of endowed positions (chairs, professors, or lectures) at Sac State. The Executive Committee, on behalf of the Faculty Senate, due to the exigency of the matter, recommend the Establishment and Administration of Endowed Chairs and Professorship Policy be an interim policy on this matter thorough the end of the calendar year, December 31, 2019. A memo to the President will be forwarded and the action will be placed on the Senate agenda as Consent Information. A referral to the Faculty Policies Committee was made with recommendations due to the Senate Chair by October 15, 2019.
