### **Open Forum:**

- **Positive Press in Sacramento Bee**: Holl noted several recent items in the Sac Bee related to positive developments at Sac State.
- **Herkey Streetcar:** An inquiry was made to having benches provided at the stops. The Chair will follow up with VP Hayano.
- **19<sup>th</sup> Annual Sacramento Music Festival:** Sheppard shared information on the event and stated that a Sacramento State student's film made the cut.
- Zero Cost Course Materials (ZCCM): The campus complied with SB 1359 to designate courses with Zero Cost Course Materials (ZCCM), our campus was the only one in the CSU system to also designate courses with Low Cost Course Materials (LCCM), those under \$40. The Chancellor's Office is interested in using our model as a guide to the rest of the CSUs.

## From the Chair:

**Program Proposals Update**: The Chair met with CPC Chair Kelly and Curriculum Subcommittee Chair Chalmers regarding the Executive Committee's concerns of how proposals come to Exec. Per Chair Chalmers, there are various levels of quality sent from the Colleges. Chalmers would appreciate having the Executive Committee recommend expectations of what they want to see from the Colleges. She will follow-up in November with the Senate Chair.

The Chair stated that Exec needed to determine what they want to see, especially around consultation. Sheppard stated that a definition is needed of what non-substantive is. Bowie felt that the importance of consultation needs to be shared with the college committees. The Chair will follow up with the Curriculum Subcommittee Chair. The item will be placed on the October 2 agenda.

- Herkey Streetcar Congestion around Capistrano Hall: ABA will be having a conversation about the situation next week and VP Hayano will follow-up with the Chair after the meeting.
- **Free Parking Permits provided for Research Participants:** Director Lucas will follow-up with the individual making the request.
- **Enforcement of no-wheeled vehicle areas:** Per Chief Iwasa, enforcement is taking place and stickers are posted in those zones. Exec felt that the stickers are not being observed. The Chair will speak to the President on the dangers of walking on campus.
- **Course Definition Work Group**: The Work Group has not met since it was established last spring. The Work Group was given an extension to December to complete their work. The Chair stated that Exec needs to review the Course Definition item again.

**From the Provost**: The Labor Relation position has been filled. The start date is October 15. The call for proposals for the GI 2025 funds has been sent out. Academic Affairs and Student Affairs are working together on a proposal for integrated advising. The College of Business Administration is going through a reorganization.
